3. Important Notes

- * Attach sufficient evidence to support your application for SFE concession. Your evidence must show that all properties are used as the one single farming enterprise (e.g. business records or taxation office statement).
- * Should your application be refused, you may appeal to the South Australian Civil and Administrative Tribunal. The appeal must be made within 28 days after you are informed of the decision to refuse your application.
- * If the circumstances upon which the land is combined for assessment as one contiguous group and/or SFE change, the owner of the land must immediately inform the Commissioner of State Taxation of the relevant changes. A maximum penalty of \$2,500 applies for failure to inform the Commissioner of the changes.
