# TAXATION ADMINISTRATION ACT 1996 CHANGE OF INTEREST RATE - FROM 1 JULY 1999

Section 26 of the *Taxation Administration Act 1996* provides for the interest rate to be applied in cases of a tax default or refund following a taxpayer's successful objection or appeal against an assessment by the Commissioner.

The interest rate comprises a "market rate" and, in respect of defaults, an additional 8% per annum. The "market rate" reflects the rate applicable from time to time under Section 214A(8) of the *Income Tax Assessment Act 1936* (Cth) or the rate specified by order of the Treasurer and published in The South Australian Government Gazette.

Effective 1 July 1999, the Commonwealth will no longer publish the "market rate" under the *Income Tax Assessment Act 1936* (Cth). Accordingly, pursuant to Section 26 of the *Taxation Administration Act 1996*, the Treasurer has specified by way of Notice in The South Australian Government Gazette, dated 17 June 1999 (page 3120), a "market rate" of 4.8% (effective 1 July 1999).

From this date, the interest rate in respect of tax defaults will be 12.8% per annum (comprising the "market rate" of 4.8% and 8%). The interest rate in respect of successful taxpayer objections and appeals will be 4.8% per annum.

The following interest rate table shows the effective interest rate for refunds and tax defaults since the commencement of the *Taxation Administration Act 1996*.

| 1 January 1997 to 30 June 1997  | 10.5%   | 18.5%    |
| 1 July 1997 to 31 December 1997 | 9.8%    | 17.8%    |
| 1 January 1998 to 30 June 1998  | 8.8%    | 16.8%    |
| 1 July 1998 to 31 December 1998 | 8.8%    | 16.8%    |
| 1 January 1999 to 30 June 1999  | 8.8%    | 16.8%    |
| 1 July 1999 onwards             | 4.8%    | 12.8%    |
