

Stamp Duties Act 1923

Revenue Ruling SDA006

Application for *Ex-Gratia* Relief for service/ex-service persons

Use this application to claim *ex gratia* relief of up to \$132 of the stamp duty paid on the purchase of a place of residence.

Ex gratia relief may be available where the applicant:

- is not otherwise entitled to an exemption under the *Stamp Duties Act 1923*;
- is a recipient (or the widow or widower of a recipient) of the Australian Active Service Medal 1945 to 1975 and/or the Australian Active Service Medal for service;
- will, or intends to, reside in a house on the land that has been purchased; and
- has not already received *ex gratia* relief under this provision.

Evidence of receipt of the Australian Active Service Medal 1945 to 1975 and/or the Australian Active Service Medal must be provided. Evidence may include:

- a certificate awarding the medal(s);
- a letter advising of the award; or
- a signed declaration (see Section Three), from a Justice of the Peace or a member of the Australian Defence Force (ADF) of the rank Warrant Officer Class Two (E) and above, stating they have sighted the medal(s).

PLEASE NOTE: Please complete an *Application for exemption for service/ex-service persons* if you were on active service in one or more of the following proclaimed areas:

- World War II (between 3 September 1939 and 31 December 1945);
- Korea (between 25 June 1950 and 25 November 1960);
- Malaya (between June 1948 and November 1960);
- Malaysia (between 16 September 1963 and 30 September 1967); or
- Vietnam (between 31 July 1962 and 23 December 1973);
