CALCULATION OF LIFE INTERESTS

Circular No. 166 (at page 8 - Life Interest and Remainder Interest), states that where a life interest or a remainder interest in property is to be conveyed, the value of the interest passing will be determined with reference to tables produced by an actuary.

Attached to this Circular is a table of life tenant factors based on the latest published Australian Life Tables.

These Life Tenant Factors are to be used in situations where a life interest or a remainder interest is to be determined for stamp duty purposes.
